# **Radium Levels Below State Standard**

Recent water tests confirm Perry Park Water and Sanitation District's (PPWSD)'s water remains below the Environmental Protection Agency's limit of 5 picocuries per liter (pCi/L) for radium. The latest test result, received December 2, was 3.9 pCi/L. This test follows an October 15 test that lowered PPWSD's guarterly average to below 5 pCi/L. On October 23, the Colorado Department of Public Health and Environment (CDPHE) rescinded the PPWSD's radium violation. CDPHE's next required guarterly test will be in the first guarter of 2025.

Radium, a naturally occurring element in Colorado's rock formations, can leach into groundwater sources. Radium has been measured in water sources for communities on the Front Range. Historically, radium levels in Perry Park have remained within the standards set by EPA. This unexpected spike required additional treatment steps, including increased filter cleaning and increased use of potassium permanganate, a standard treatment chemical that reduces radium levels.

The August 2024 test revealed radium levels in drinking water above the government standard. The sample, measuring 12.9 picocuries per liter (pCi/L), brought the PPWSD's quarterly average for radium to 5.7 pCi/L, 7/10ths of a percent above the Environmental Protection Agency's (EPA) limit of 5 pCi/L, which is the limit allowed by the CDPHE.

"PPWSD is pleased our water quality team has been able to make adjustments to treat the water to meet the EPA and state standards, PPWSD is investigating long term treatment solutions," said District Manager, Diana Miller. "We will continue to monitor this situation closely and report updates to our customers."

#### **Perry Park Increases Surface Water Supply**

In its ongoing effort to use more renewable surface water and secure additional groundwater wells, the PPWSD is pleased to report it has completed work at Gove Ditch.

A measuring device was installed at Gove Ditch that allows the PPWSD to track water flowing in the stream and trade or exchange this water for additional surface water closer to our infrastructure.

In 2024 the District also brought the New Dakota well online, providing a new water source for the west side of Perry Park. Redrilling and bringing this well online will provide additional water for drinking and to help with fire protection on the west side.

On the District's east side, construction on the Poncho well is almost complete. After a new pump and permanent electricity are installed, the Poncho well will serve as a new water resource for the PPWSD. This additional water supply is especially important because Perry Park's east side is prone to lightning strikes and will make additional water available should a lightning strike hinder other east-side wells.



### **Winterizing Your Pipes**

Colder weather has signaled it's time to winterize. Broken pipes can cause serious damage. The simple steps outlined below will ensure a safe transition into the colder temperatures.

- **Insulate pipes exposed to cold air.** These are the pipes adjacent to exterior walls or crawl spaces.
- Set your home's thermostat no lower than 65 degrees, even if you are away.
- Seal openings allowing cold air inside.
- Properly shut down and blow out your sprinkler system.
- · Disconnect, drain, and store all water hoses.
- **Keep faucets dripping cold water**, especially the ones furthest from the main valve. Moving water prevents freezing.
- Open cabinets and vanities to allow warmer air to circulate around pipes.
